- Companies are eligible to apply to eight categories by paying single fee as mentioned above.
- In case company is applying for corporate level awards then Plant Level application cannot be submitted under those Categories.
- There is no fee for small category companies applying to all applicable categories
- Fee is completely waived off (all eight categories) only at plant level where more than 15% women employees or more than 5% differently abled employees are working
- This waiver is not applicable for corporate level.

# Plant-Level Fee Waivers (Not applicable for Corporate Level)

- Free if:
  - o Company is Small (up to ₹100 Cr Company Group Turnover), or
  - o Plant employees ≥15% women or ≥5% differently abled
- Must submit signed declaration in the template provided during registration.

# Important Note on Eligibility for last year (2024) Platinum Award Winners - Eligibility Restrictions

Organizations (either at the corporate or plant level) that received a Platinum Award in the previous year are not eligible to apply in the same category for this year. However, they are welcome to apply in any other category, as applicable.

# **Application Process**

### Steps:

- 1. **Register** → Get login credentials (within 24 hrs)
- 2. Fill Company Profile → Await ACMA approval
- 3. Submit Part 1:
  - o Enter 10 Common KPIs
  - Select categories (all 8 eligible in single Plant-level fee)
  - o Only 5 KPIs per selected category to be filled
- 4. Schedule Site Assessment
- 5. Submit Part 2:
  - Common + Category-Specific Questions
  - o Deadline: 3 days before site visit
- 6. Site Assessments: Complete by November 30, 2025

# **Mandatory:**

- Upload accurate data
- Include **3 customer details** (only for Export & Manufacturing)
- Submit both Part 1 & Part 2

Incomplete or incorrect submissions will be disqualified.

# **Evaluation Process**

- Marks: Out of 500
- Assessment Rounds:
  - 1. Document Review
  - 2. Virtual Site Visit (July 20 Nov 30, 2025)
  - 3. Final Jury Evaluation (Dec 2025)
- Evaluation Metrics:
  - o KPIs
  - o Customer feedback
  - o Process excellence
  - Leadership involvement
  - o Business & sustainability impact
